

**CLIMBING WALL RELEASE / INDEMNIFICATION OF ALL CLAIMS
AND COVENANT NOT TO SUE**

NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. By signing this agreement, you give up your right to bring a court action to recover compensation or obtain any other remedy for any injury to yourself or your property or for your death however caused arising out of your use of the Climbing Wall, now or any time in the future.

ACKNOWLEDGMENT OF RISK

I HEREBY ACKNOWLEDGE AND AGREE that the use of the Climbing Wall (hereinafter referred to as the Climbing Wall) has inherent risks. I have full knowledge of the nature and extent of all the risks associated with use of the Climbing Wall, including but not limited to:

1. All manner of injury resulting from falling off the Climbing Wall and hitting rock faces and projections, whether permanently or temporarily in place, or the ground;
2. Rope abrasion, entanglement and other injuries resulting from activities on or near the Climbing Wall such as, but not limited to, climbing, belaying, rappelling, lowering on rope, rescue systems, and any other rope techniques;
3. Injuries resulting from falling climbers or dropped items, such as, but not limited to, ropes or climbing hardware;
4. Cuts and abrasions resulting from skin contact with the Climbing Wall;
5. Failure of ropes, slings, harnesses, climbing hardware, anchor points, or any part of the Climbing Wall structure.

I further acknowledge that the above list is not inclusive of all possible risks associated with the use of the Climbing Wall and that the above list in no way limits the extent or coverage of this release and covenant not to sue.

RELEASE / INDEMNIFICATION AND COVENANT NOT TO SUE

In consideration of my use or the use by my Son/Daughter/Ward of the Climbing Wall, I, _____, the undersigned, agree that I and my heirs, distributees, guardians, legal representatives, and assigns will not make a claim against, sue, attach the property of, or prosecute Word of Life, Bermuda (hereinafter referred to as "The Company"), any of its Directors, officers, trustees, employees, or agents, (all the foregoing listed being hereinafter designated "releasees") for any injury, death, or property damage occurring to me or my Son/Daughter/Ward as a result of participating in the use of the Climbing Wall with The Company, whether caused by the negligence of The Company or otherwise and whether my use or the use by my Son/Daughter/Ward's participation is supervised or unsupervised. In addition, I release and discharge The Company and all of the other releasees from all actions, claims, or demands that I and my heirs, distributees, guardians, legal representatives, or assigns now or in the future may have for any injury, death, or property damage resulting from my use or the use by my Son/Daughter/Ward's use of the Climbing Wall conducted by The Company.

I agree for myself and my heirs, distributees, guardians, legal representatives, and assigns that in the event that any claim for personal injury, death or property damage shall be prosecuted against The Company, and/or any or all of the other releasees, I shall indemnify and save harmless The Company and/or all of the other releasees from any and all such claims or causes of action by whomever made and wherever presented.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in the use of the Climbing Wall and that I voluntarily assume the risks. I understand that I will be solely responsible for any loss or damage, including death, I or my Son/Daughter/Ward sustain while using the Climbing Wall and that by this agreement, I am relieving The Company of any and all liability for such loss, damage or death.

I further certify that I or my Son/Daughter/Ward is in good health and that have no physical limitations, which would preclude my use or the use by my Son/Daughter/Ward's safe use of the Climbing Wall.

I further certify that as my Son/Daughter/Ward is presently a minor and not legally competent to sign this agreement, I am signing this agreement to hereby give my consent to my Son/Daughter/Ward to use the Climbing Wall and I certify that I am signing this agreement, after having carefully read it, of my own free will. **IN WITNESS WHEREOF**, this instrument is duly executed at _____, this _____ day of _____, 20_____.
